Pledge of Allegiance

Sean DeSarbo and the Leadership Team from Paddock Elementary School presented the Paddock Elementary School Improvement plan to the Board.

Nichole Kuenzel presented the First Reading of the Reproductive Health Curriculum Changes to the Board.

The Board heard Public Comments Regarding the Proposed Reproductive Health Curriculum. No comments were made.

Krista Hendrix presented the First Reading of the 2018-2019 General Fund Budget Amendment as detailed in Attachment A.

Superintendent's Comments:

Students

- On November 18th, Superintendent Girbach attended the MHS play "Almost Maine". The students did a tremendous job! The play was very entertaining. Thank you to the students, the director (Courtney Jeffers), and the staff.
- As part of a new Chartwells' program called "Student Choice", MHS students enjoyed food sampling and voting today during lunch. The students sampled and voted on three different line options. The winning option will be made available on Fridays for the

next few months. The students will then have a new sampling and voting day to select a new line option.

Staff

- Rebecca Forinash's (MMS Paraprofessional) sister passed away last week.
- Effective January 1, 2019, Milan Area Schools will be switching from American Fidelity to EHiM for our HRA services. This switch will make health care reimbursements under our high deductible plan much easier for our employees.

General

- MAS in partnership with EMU and numerous other entities have been approved for final application for a Marshall Plan Grant. Principal Shinn and Superintendent Girbach have been working with EMU on the application. If the grant is approved, Milan will receive \$500,000 in teacher training and supplies to support engineering and manufacturing curriculum.
- The Washtenaw Futures Group will be preparing an application for the second round of the Marshall Plan grant program. This application will help fund college coaches for high schools in the county.

Communication

- The district currently has 756 Twitter followers. That is up 3 from last meeting.
- The district currently has 1,575 Facebook followers. That is up 0 from last meeting.

Budget

- During the months of January and February, following the December Budget Revision, the Board will be discussing facility needs, technology needs, curricular needs, and staff compensation.
- The district has finalized a Copier Lease. The new equipment should be installed sometime in the next 2 months.

• The Milan21 team had a work day on Monday, November 6th. The team will be providing Professional Development in each of the buildings on December 12th. The PD will focus on instructional strategies to increase Critical Thinking in the classroom.

 Assistant Superintendent McMahon reminded the Board and community that the Reproductive Health Survey is still open and accessible via our website. The survey will close on Nov. 30. Currently there are over 400 responses, which is very much appreciated.
