- Cislo referred to the passed Resolution regarding Policy No. 9130 in response to questions and attempted to respond to questions related to the Board goal setting activity.
- Faro explained that book challenges would still be accepted and would be reviewed in the future, reminded the community about upcoming High School parent-teacher conferences, thanked Ms. Mocchio for her service, and offered clarification in response to questions related to the Board goal setting activity.
- Meray thanked community members and Mrs. Moccio for participating in the Downtown Read Around. She also promoted the MHS and MMS musicals.
- Heikka explained that she did believe certain comments did incite the recent threats
  received by Board members and their families, her thoughts on allegations related to
  sexual assault, the disruption the criminal complaint is causing, explained that she
  believed the District was in compliance with various state statutes, and expressed her
  belief that community members reading portions of various books to minors in Board
  meetings must also believe that the books do not violate state statutes.
