## **Assistant Superintendent's Comments:**

Assistant Superintendent McMahon shared that the Consolidated Application and the Title I School Selection applications have been approved by MDE.

Assistant Superintendent McMahon provided an update on CARES Act grant funds. The district is in the process of applying for the second round, called the ESSER Education Equity Fund, which is potentially a little more than \$20,000 for MAS. MAS does not qualify for the third round of CARES Act Funds based upon the percentage of economically disadvantaged students.

Assistant Superintendent McMahon commended the principals for all of the extra work they have been putting into preparations for the start of the year.
